Brief profile of Mr. Shreekant Somany

Mr. Shreekant Somany is a well known industrialist and is currently Chairman and Managing Director of Somany Ceramics Limited (SCL). He joined family business after graduating from Calcutta University (B.Sc.) in the year 1969 and did his training in SIMILOR, SA Geneva (Switzerland).

SCL offers the widest range of ceramic tiles in the country and has a strong pan India sales distribution network and also exports its material to various countries across continents.

Mr. Somany has been instrumental in making SCL becoming the first Indian ceramic tile company to have received PATENT under Indian Patent Act for its revolutionary "High Abrasion Resistant Glaze Composite" known as VC (Veil Craft) Shield.

Mr. Somany is a recipient of the prestigious Corporate Technical Achievement award from the American Ceramic Society in the field of ceramics for development of Somany Veil Craft Shield Floor Tiles.
