6. POINT XII - PENALTY AND PUNISHMENT - DETAILS THEREOF: NIL

Update on last year's Order of Competition Commission of India (CCI): On 2nd February 2022, Competition Commission of India (CCI) published an Order dated 31st August 2018, for alleged contravention of Section 3 of the Competition Act, 2002 against JK Tyre & Industries Ltd. ("Company") and certain other domestic tyre manufacturing companies and imposed a penalty of Rs. 309.95 Crore on the Company and a penalty of Rs. 16.45 Lakh under Section 48 of the Competition Act, 2002 against Director & President - International of the Company.


The Company and Director & President - International filed Appeals on 29th March 2022 before the Hon'ble National Company Law Appellate Tribunal ('NCLAT') against the said CCI Order dated 31st August 2018.

The NCLAT, through an Order dated 1st December 2022, has disposed of the aforementioned appeals, after taking note of the multiple errors in the said CCI Order dated 31st August 2018 and remanded the matter back to the CCI, to re-examine the matter on merits and also to consider reviewing the penalty (if violation is established) in accordance with the provisions of the Competition Act.

The CCI has filed an appeal before Hon'ble Supreme Court of India, against NCLAT order dated 1st December 2022. Based on legal advice, the Company continues to believe that it has a strong case, and accordingly, no provision has been made in the accounts. The Company strongly reiterates that there has been no wrongdoing on the part of the Company and reassures all the stakeholders that the Company has never indulged in or was part of any cartel or undertook any anti-competitive practices.


